We are keen to strike a fair balance between your personal privacy and ensuring you obtain full value from the internet and other products and services we may be able to market to you.

## Personal Information

### Use of Information

We may also use transactional data to update your profile so that we can offer you similar products that may be of interest to you based on this data. The information you provide will be kept confidential and will be used only to support your customer relationship with us. We do not disclose or sell your information outside our corporate group except if we sell the whole or part of our business.

## Trading from our website

Making sure you can buy safely online is a priority for us and we have made strenuous efforts to ensure that store security is one of our highest priorities and we have devoted a great deal of effort to ensure that our online security measures help to safeguard your information. We use industry-standard Secure Sockets Layer (SSL) technology to allow for the encryption of potentially sensitive information such as your name and address.

In respect of the payments made by you through our website we have outsourced to PayPal the collection of all credit and debit card payments which are subject to the same high SSL

encryption standards and security as referred to above. We do not store credit card details nor do we share customer details with any 3rd parties.

You may also make payment via your PayPal account, during this process you will be redirected to the PayPal website again, **We do not store credit card details nor do we share customer details with any 3rd parties**.

We take the security of your personal data very seriously and trust that the payment methods and procedures set our above reflect this. It is also your responsibility to keep your personal data safe. By our joint efforts we believe that your order with PTSD Resolution should be safe, secure and efficient.

## **Tracking**
